



It is recognized worldwide that to fight climate change, buildings should use 100% renewable energy, becoming what are called Zero Energy Buildings.

The International Living Future Institute's (ILFI) **Zero Energy (ZE) Certification™** was created to allow leading projects to demonstrate this true zero energy performance.

The International Living Future Institute (ILFI) 零耗能 (ZE) 认证是为了让引领趋势的项目得以示范它们零耗能绩效。

The program is the only international zero energy certification to verify buildings that operate using 100% renewable energy and without the use of on-site combustion.

Certification is administered through a third-party audit of the building's performance data. 此计划是唯一的国际零耗能认证，鉴定建筑体是使用100%再生能源，而非当地燃料。认证需透过第三方审核建筑体的绩效数据。

To spur market development in China ILFI will be offering Free Zero Energy project registrations and discounted certification for the first 10 ZE projects.

PROGRAM REQUIREMENTS:

计划要求：

One hundred percent of the building's energy needs on a net annual basis must be supplied from on-site renewable energy. No combustion is allowed.

建筑体的能源需在年净值上百分之百的来自当地再生能源，不能有燃料参杂其中。

PROGRAM EXCEPTIONS:

计划例外情况：

There are three instances where we allow projects to claim renewable energy from off-site: 有三种情况我们是允许项目使用非当地的再生能源，三种情况如下：

1. When a building has high energy intensity or density, and even with the highest levels of efficiency is not able to offset their energy use onsite
当一栋建筑物有高能源强度或高能源密集度，就算有着高效能也无法抵消建筑体的能耗量。
2. When the project owner does not control the exterior of the building
当项目负责人不控管建筑外墙。
3. When the local grid cannot accommodate the renewables created by the project
当本地电网无法负荷项目所生产的再生能源。

4. CERTIFICATION 认证

If the auditor and staff determine the project meets requirements, it will be certified!

Certification is \$2,000 US for single-family residential and starts at \$3,000 US for commercial projects.
